
BACKGROUND

A bylaw of the Town of Claresholm to authorize the collection of electoral information for the Chief Electoral Officer of Alberta.

WHEREAS, pursuant to the *Local Authorities Election Act*, S.A., 2000 Chapter L-21 with amendments thereto, a municipality may, by Bylaw, direct the Chief Administrative Officer to prepare a permanent register of residents in a municipality who are entitled to vote in an election.

NOW THEREFORE, the Council of the Town of Claresholm, in the Province of Alberta duly assembled, hereby enacts as follows:

TITLE

1. This Bylaw may be cited as the "Electoral Information Bylaw."

DEFINITIONS

- 2. In this Bylaw:
 - a) "Municipality" means the corporation of the Town of Claresholm.
 - b) "Chief Administrative Officer" means the CAO of the Town of Claresholm.

PURPOSE

- 3. The Chief Administrative Officer, or his/her designate, for the Town of Claresholm is hereby authorized to prepare a permanent register of residents entitled to vote in elections.
- 4. The Chief Administrative Officer, or his/her designate, is authorized to:
 - a) Establish the procedures and forms necessary to complete an enumeration.
 - b) Establish methods of compiling and revising the permanent electors registry.
 - c) Enter into an agreement with the Chief Electoral Officer und the *Local Authorities Election Act* to share information for the purpose of preparing a Provincial list of electors.
- 5. This bylaw shall come into force on the day of the final passing thereof.

Applicant would like to rezone the subject lands to a Residential (R1) designation. He intends to build one single family residential dwelling.


BACKGROUND

The subject lands have an area of 649 square metres (6991 square feet) and is currently zoned Public (P). The land is used as parking for the office building located to the east. Single Family dwellings are built to the west and south of the subject lands; however the residential zoning to the north is vacant.

<u>ISSUES</u>

The amount of parking that the rezoning takes away from the office building will not affect the total amount of parking needed, as there will still be ample parking available. 

PARKING AND ACCESS REVIEW

PARKING:

Demonstrated below is the configuration of the onsite parking with the removal of lot 16. The arrows depict the parking banks with the corresponding liner feet beside them. There is 315 liner feet of parking onsite. This translates into 31.5 parking spaces (10 foot parking stall width [Claresholm Land Use Bylaw; Schedule 8; subsection1]).



Having approximately 30 parking stalls greatly exceeds the 10 spaces required by the Claresholm Land Use Bylaw [Schedule 8; Subsection 6]. By rezoning lot 16 the building is only loosing a row of rear parking, not changing the remaining existing parking layout.




BACKGROUND

The province recently announced \$285 million in new funding in response to the recommendations brought forward through the Alberta Affordable Housing Task Force. High-growth communities will receive a total of \$143 million in support of affordable housing to meet growth pressures within their community.

An additional \$68 million is available to other communities that can demonstrate a need for affordable housing and have identified a suitable project. Communities that received funding from the \$143 million initiative, but received less than \$3 million, are also eligible to apply for additional funding. Municipalities can apply through a Request for Proposal process until August 31, 2007. Information on the process and an application form are available on our website at www.municipalaffairs.gov.ab.ca.

Proposals can involve the construction of new rental units, the purchase and renovation of existing rental accommodation, conversion of non-residential space to residential units, the development of secondary suites as affordable housing, rent supplements or other priorities identified by the municipality.

BACKGROUND

The 2007 provincial budget provides Alberta municipalities with an unprecedented \$400 million in new investment through the Municipal Sustainability Initiative (MSI). By 2010-11, \$1.4 billion will be provided to municipalities to assist them in achieving sustainability. This is equivalent to the education property tax currently collected in Alberta.

The Association strongly endorses the vision of the Government of Alberta to further invest in Alberta municipalities. The pressures created from the phenomenal economic growth in Alberta over the past few years have been well documented and are recognized by all government partners. We applaud the Government of Alberta for the creation of the MSI and feel that with some refinement of the allocation methodology, this program will help municipalities manage growth pressures, deal with a backlog of capital projects, and address the increasing cost of providing quality municipal services to Albertans.

This submission is intended to be forward-looking, and is not intended to suggest that Year 1 funding should not occur as announced.

KEY PRINCIPLES

AUMA recommends that the MSI funding should be based on the following principles.

1. Linkage with Provincial Revenues – The provincial tax base is linked to the economy, and thus municipal revenues should also follow the economy. Municipal governments exist for the long-term, and are moving more and more towards long-term planning. In order to effectively implement long-term plans, municipalities must, to the degree possible in having funding tied to the economy, have corresponding long-term, predictable and sustainable funding. While municipalities have access to own-source revenues such as fines and penalties, charges for services, and investment income, the bulk of their revenues come from the property tax, and grant funding from other governments. This does not lead to balanced growth in regions due to the competition for property taxes (no other major revenue sources). Revenue linkage gives municipalities greater revenue diversity to meet the complexity of service and infrastructure demands, while at the same time recognizing that municipalities cannot expect to only share in the fruits of a growing economy, but rather, municipal governments' revenues should grow and shrink as the Alberta economy ebbs and flows. The result is a true partnership between the province and municipalities, featuring effective long-term planning, and a better capacity for achieving municipal sustainability.

2. Community Sustainability -

- a. Communities need the ability to plan and implement their own long term sustainability initiatives. Community priorities have to be set by that community not through complex provincial conditional grant systems. Municipalities have to consider all factors that impact the long term sustainability of their communities. Rather than receive conditional funding, each municipality should complete a long term sustainability plan which prioritizes its critical infrastructure needs and, based on this plan, it should submit to the Provincial Government an audit of its sustainability priorities, including how the MSI addressed those priorities.
- b. Municipal governments will track sustainability through a new Audit and Performance Measurement System and action will be contemplated where the Audit discloses an issue with sustainability. Due to external forces and changes occurring over time, local governance structures will sometimes have to change. Sometimes this is a matter of gaining economies of scale through regionalization, and sometimes this is a matter of declining viability or sustainability of communities. In cases where a solid argument can be made for improved sustainability through regionalization, a process should be put in place for considering this course of action. In cases where

municipalities cannot sustain themselves, other options for their governance, including dissolution, should be considered. This concept was highlighted in the convention-approved AUMA Paper on "Formation, Fundamental Changes and Dissolution" (2004) and is discussed in the recently approved AUMA Position Paper entitled "Multi-jurisdictional Planning" (2007).

- 3. Complementary funding—MSI funding should not replace existing grant programs. Alberta municipalities face increasing costs for providing quality services and eliminating the infrastructure deficit. In addition, extreme differences in revenue-raising capacity exist amongst Alberta municipal governments, and there are disparate effects of provincial grants upon them¹. The MSI should provide a new source of funding for all to complement existing permanent programs, until such time as municipal and provincial responsibilities and education taxes and grants are reviewed as recommended in the Minister's Council Report.
- 4. Equitable funding— MSI contributions should provide all municipalities with a minimum amount of funding. MSI funding must provide a base amount of money to all Alberta municipalities, so that each municipality is provided with enough cash to carry out priority projects, especially given that, with the conclusion of the Alberta Municipal Infrastructure Program (AMIP), smaller municipalities will be at a substantial loss of funding without a base amount within MSI.
- 5. Autonomous decisions— Funding should enable municipalities to meet their own priorities. Municipalities are in the best position to determine where funds should be allocated. It is important to allow municipalities the ability to determine how the greatest overall benefit for the municipality can be derived. Enhanced municipal autonomy was a major consideration in adopting new municipal legislation in Alberta in 1994.
- 6. Simple process without competition Program simplicity increases the value of funding. Competitive programs, tight restrictions on fund use and detailed reporting can all impact on the value that municipalities are able to derive from the MSI funding. Competitive programs typically require comprehensive applications, adjudication and reporting processes. While the AUMA understands that accountability is paramount, there is concern with how competitive processes impact the ability to secure funding. Another challenge inherent in a competitive process is that of potentially rewarding funds to those municipalities which have reached a crisis point because of previous poor or insufficient planning, while those municipalities which have planned well and invested well in their infrastructure are overlooked. Additionally, overly onerous requirements may result in program delays that negatively impact planning cycles. In Alberta, there are already existing funding programs to look to as precedents that maintain accountability and provide

changes in individual support programs may have differential effects on particular municipalities or groups of municipalities

the net impacts of concurrent changes in municipal responsibilities, provincial support programs, and education taxes may differ widely by type or size of municipality and from municipality to municipality

potential impacts must be examined on a disaggregated municipal basis as well as in terms of aggregate effects

municipalities with greater flexibility through a system of robust project criteria and post-project audit sampling.

ISSUES

Based on the foregoing principles, the following issues exist with the MSI.

- 1. Disparity of sustainable and equitable funding. The MSI is to be fully implemented at the same time as the Alberta Municipal Infrastructure Program (AMIP) ends. AMIP provides a base amount of funding for every municipality whereas the MSI does not. As a result, the completion of AMIP and ramping up of MSI can result in a lack of viability for those municipalities currently in high financial need. Moreover, the magnitude of the impact resulting from the funding will vary among municipalities. Based on the current allocation formula, some municipalities will not receive enough funding to do anything substantial to properly address local needs.
- 2. Limited municipal autonomy through placement of conditions on funding without any real corresponding increase in accountability. To address key provincial priorities the MSI funding is divided into numerous "envelopes". While this appears to be a well-intentioned mechanism to meet the needs which have been expressed to the GOA, in reality this will only serve as a barrier to meeting the needs of Albertans. Over-regulation of funding conditions may result in the allocation of funds to non-priority areas. Conditional funding assumes that municipal needs are the same across all municipalities and that they align with those of the Province. This is at odds with "place-based" decision making and limits a municipality's ability to address local needs. Municipal governments are in the best position to understand the needs of their ratepayers. Overall, the highly conditional nature of the MSI is not congruent with the philosophy of enhanced municipal autonomy that was used to develop Alberta's Municipal Government Act, nor does an emphasis on conditions actually enhance any accountability tied to ensuring the funds are well spent on appropriate matters.
- 3. Implied transfer of housing responsibility. The MSI provides municipalities with funding for affordable housing projects. This implies a transfer of responsibility for affordable housing from the Province to municipalities. This contradicts recommendation 6 of the final report of the Minister's Council on Municipal Sustainability (MCMS): "No major realignment of current municipal and provincial roles and responsibilities is required". Furthermore, the Council recommended further addressing the shared responsibilities of affordable housing, ground ambulance and policing by September 2007, and it is expected that the Council members will explore this jointly.

During Year 1 of MSI, municipalities will use the funding provided to carry out affordable housing projects. However, this is not a solution to the housing situation. Municipalities are currently calculating the investment required to meet affordable housing challenges.

While not yet complete, early indications suggest that funding demands will be much greater than what is currently provided under the MSI. This designation of funds can be expected to build expectations among ratepayers that municipalities cannot meet.

Therefore any changes in municipal responsibility should be separated from the MSI program – the MSI funding relates to existing responsibilities and the revenues required to plan, implement and sustain those accountabilities. AUMA intends to develop a separate submission to the Government of Alberta on the housing responsibilities for the different orders of governments and any changing funding requirements related to changes in responsibilities.

4. Over-emphasis on incentives for inter-municipal cooperation. A significant portion of the MSI funds are tied to inter-municipal cooperation. While AUMA supports inter-municipal cooperation, it

is most meaningful and progressive when it is truly voluntary. As noted in the final report from the MCMS, municipal cooperation already occurs throughout the province.

There are challenges to what amounts to "compulsory" inter-municipal co-operation. For example, where one municipality has multiple neighbouring municipalities it may not be possible to accommodate all of the projects. In some cases, some municipalities may not have the capacity to meet the expectations of their neighbours for collaboration. In other situations, a municipality may not have neighbours with which to partner. In other cases, there are municipalities that wish to cooperate, but have a neighbor that is not interesting in cooperative projects — the result is a penalization to the neighbor that wishes to take on cooperative efforts. The co-operative component of the MSI could place some pressure on municipalities to favour collaborative projects over priority projects identified in long-term plans (both statutory and non-statutory).

5. **Light Rail Transit:** While not specifically mentioned in the MSI, light rail transit deserves mention as an issue in the same way that affordable housing is discussed above. Both Calgary and Edmonton currently operate light rail transit systems. These systems are needed in areas with high population and complex transportation needs. The Governments of Alberta and Canada need to recognize those requirements and how important light rail transit is to the major cities leading economic diversification. A light rail transit program for the two major cities needs to be implemented and funded by the two Governments, separate from the MSI.

RECOMMENDATIONS

As stated, the AUMA and AAMDC believe that the MSI is a strong commitment from the Government of Alberta to adequately address local priorities in Alberta municipalities. We further believe that the following recommendations will enhance the MSI and overall municipal sustainability.

- 1. Establish a Formal Provincial-Municipal Agreement that includes a Permanent Funding Mechanism and a Partnership/Engagement Mechanism. The Government of Alberta should implement a permanent transfer of provincial revenues that follows the economy of the Province, rather than a ten-year commitment. This will provide municipalities, to the degree possible in having funding tied to the economy, with a source of predictable, sustainable funding and will enable long-term planning. This should be formalized through an agreement that outlines the amount of funding and includes a process for effective engagement and enhanced provincial-municipal relations. Municipalities' plan and support infrastructure that lasts for centuries. Revenue sources have to align with that long range planning horizon, governance demands and long term maintenance requirements.
- 2. Establish the following components to be included in the Allocation formula of the new Fund:
 - A Base Funding² component that ensures municipalities with low assessment bases receive a base funding:

After 2010, when the Alberta Municipal Infrastructure Program is complete, the total amount of the base funding component (\$100 Million) will rise by the same percentage as the municipal revenue sustainability component (see "Municipal Revenue Sustainability" below).

- An Equalized Assessment component of \$250 million that would be distributed to municipalities based on their contribution to the education property tax component. This amount would be fixed until 2010 after which the amount would change by the difference in the total Provincial Education Tax requisition and \$1.2 billion. This would provide municipalities with the operating support to meet demands in growing communities but would also be adjusted each year by the Provincial Education Property Tax requirements (if they reduce then this amount reduces).
- A **Municipal Revenue Sustainability** component that is fixed to targeted Provincial Revenues and distributed on a per capita basis to municipalities. The funding under this component would increase from \$150 million in 2008, to \$250 million in 2009 and \$1,050 million in 2010 when the AMIP program has been completed and the funds transferred to this program. In 2010 the future amounts will be set by the percentage of the \$1,050 million to the total amounts of the Provincial Revenues below. The Provincial revenues which the municipal revenue source would be linked to would be:
 - i. Fuel tax
 - ii. Personal income tax
 - iii. Gaming
 - iv. Natural resources (this to be consistent with recommendation 11³ of the March 2007 Report of the Minister's Council on Sustainability)

³ Report to the Minister of Municipal Affairs and Housing: Presented by the Minister's Council on Municipal Sustainability (March 5, 2007):

3. Hold municipal governments accountable for good governance and financial management through Municipal Sustainability Audit Reports rather than complex conditional grant programs. Accountability can be best attained through the establishment of a municipal sustainability audit system and performance reporting rather than through an annual transfer of conditional grants. The recommended system is to have an annual, signed auditor's report to the Government of Alberta, showing how the revenue flow has been spent to meet the sustainability obligations of the municipality. Under such an audit system, sound financial planning will be achieved and long-term planning will allow all municipalities to effectively use their revenues in the best interest of their citizens. A measure of asset performance would allow the government to know that critical asset upgrades are being completed and the citizens' needs are being addressed, while at the same time leaving Council empowered to lead its community. The sustainability audit reports would provide the Provincial Auditor General with the confidence that shared provincial revenues are being allocated based on the municipalities' highest requirements.

The audit reports could also be used to demonstrate the sustainability or viability of municipalities. There are very few municipalities which dissolve or restructure in any given year; however, there are some that are substantially supported by provincial grants. There may be alternate governance structures or different governance partnerships that could be found for those municipalities that struggle to maintain services and infrastructure with their current revenues. A possible measure of viability is the percentage of total revenues that the municipality receives as a provincial grant.

- 4. Establish a process to consider and act on changing a governance structure if a Municipal Sustainability Audit Report shows good reason to do so. There are two cases where changes may be required to governance structures. If a Municipal Audit Report shows that:
 - The benefits of achieving economies of scale through regionalization/amalgamation outweigh the benefits of maintaining distinct municipalities. (If the Audit Report can show duplication of services/infrastructure amongst neighbouring municipalities, this should trigger a cost-benefit analysis of regionalization/amalgamation).
 - A municipality is unable to sustain itself using its current property tax regime and other current revenues, and that municipality agrees to dissolve. (Then, it is recommended that the resulting or newly formed community should be eligible for double the MSI for 5 years after its dissolution, which would be applied to that community's infrastructure needs.
- 5. Establish provincial requirements for multi-jurisdictional planning processes for all municipalities. Multi-jurisdictional planning would address:
 - o growth management
 - o land use and density
 - o sustainability planning
 - o transportation planning
 - o intermunicipal dispute resolution processes
 - o tax-sharing, cost-sharing, and revenue-sharing

Establish specific Provincial direction, by Regulation, for land use planning in transition areas between municipalities, and develop greater coordination and integration of Provincial land

Recommendation 11: The Government of Alberta should consider redefining the concept of "economic rent" to include the direct costs imposed upon municipalities as a result of resource development, and provide municipalities access to revenues from industry to offset these costs through one of the following options: a. Increased provincial resource royalty rates, with the increase earmarked for allocation to directly affected municipalities; or b. Legislative amendments to authorize municipalities to raise the necessary revenues directly from resource utilizers.

management activities with multi-jurisdictional planning, including sale of Crown land to municipalities⁴.

- 6. Immediately reconvene the Minister's Council to further address Municipal and Provincial Roles and Responsibilities (recommendations 6, 7 and 8 of the Report of the Minister's Council).
- 7. Have the Government of Alberta assist with a study of the municipal infrastructure deficit. It is expected that this task will become more straight-forward as municipalities move towards reporting tangible capital assets and creating asset management systems. With renewed investments in communities by the provincial and municipal governments, all parties will have to regularly revisit the MSI fund and its effectiveness. The study would be the base for the performance reports for municipalities. This would evolve, becoming information contained in the annual financial reporting.
- 8. Develop a comprehensive Communications Strategy with the following goals:
 - To effectively communicate the proposed formula to the AUMA and AAMDC membership
 - To raise the value of municipal governments and the functions of municipal governments amongst society in general.
 - To raise the level of understanding of municipal finance (including reserves) amongst MLAs
 - To raise public awareness of the effectiveness of the MSI funding.

BENEFITS OF THE NEW PROVINCIAL-MUNICIPAL AGREEMENT

To conclude, AUMA would like to outline the major benefits arising from a new Provincial-Municipal Agreement such as the one proposed in this paper.

- 1. The Agreement will help municipal governments address critical capital and operating deficits, ultimately benefitting all Albertans.
- The funds will follow the Provincial economy, therefore providing more funding when the Province
 is growing, and communities need to respond quickly and effectively to growth and less funding
 when Provincial revenues are under pressure from economic downturns.
- 3. A Sustainability Audit Report to the Provincial Auditor General with the verification that the funds have been spent on key municipal requirements set by the community will increase municipal accountability.
- 4. The Agreement will take pressure off the need for the property tax system to meet all the growth pressures, and this is beneficial in times when the Government of Alberta runs surpluses.
- 5. Long-term financial planning will be enhanced and will be more effective for both the Government of Alberta and municipal governments.
- 6. Through provision of more sustainable and predictable revenues for municipal governments, the Government of Alberta will be in a better position to examine roles and responsibilities of government and to better align accountability.

- 7. Sustainable and predictable revenue flows for municipal governments will allow the Government of Alberta to address other critical provincial issues that are of importance to all Albertans.
- 8. If the Government of Alberta shifts responsibilities to municipal governments, the formula allows for adjustments that will ensure the new municipal responsibilities are compensated with adequate funding.
- 9. Municipalities will become better economic development partners with the Province.
- 10. The Agreement strongly re-enforces the philosophy that there is only one taxpayer supporting all orders of government.
- 11. The Agreement will form a solid foundation of the NEW DEAL for municipalities.

I am pleased to share information with you on the Alberta government's recently announced Municipal Sustainability Initiative. This commitment is part of Premier Stelmach's promise to provide new funding of \$1.4 billion to municipalities, phased in from 2007 through 2010. In fiscal year 2007-08, municipalities will see an additional \$400 million in financial support. This funding includes incentives to encourage collaboration and cooperation between municipalities.

Under the Municipal Sustainability Initiative, your municipality is eligible to receive \$186,313 in 2007-08.

Part of this funding will be provided for local projects and activities as follows:

Proposed Scheduling and Operations

Construction of the well-site and access road will require the use of heavy equipment and is planned for spring/summer 2007. After construction is complete, large trucks will be used to haul the drilling rig to the location where drilling will commence. Drilling operations, which are planned to commence in spring/summer 2007, are expected to last approximately 7 days. The equipment to be moved onto the well-site will consist of well shacks, the drilling rig, support equipment and support services.

Once drilling operations have reached the targeted depth of 2345.8 meters, completion and testing operations will begin, usually within one to two weeks. Completion and testing operations open up the formation allowing trapped fluids to flow to surface, and help determine the economic feasibility of tying the well in through a pipeline. During the well cleanup and testing, equipment will include a service rig, testing equipment and a flare stack. As weather, rig availability and progress of drilling can all affect the timing of a project, you will be advised again if significant timing delays are anticipated.

Flaring Operations

Gas flaring will be on an intermittent basis during initial clean-up flow of any productive zones and may also occur more consistently during any subsequent production testing for the duration of approximately 2-4 days. A test separator unit will be used to separate and measure produced gas and fluids. Residents within the prescribed flaring notification radius will be contacted a minimum of 24 hours before any potential flaring activity begins as per EUB Guide 60.

Traffic, Odors, Emissions, Noise

Moving the rig in to drill and out after drilling may require 20 to 30 loads of semi-sized trucks. Daily operations will include additional cars and light truck traffic required for crew transport and inspection activities in addition to use of a water and vacuum truck. However, once the well is on production, traffic will be reduced to approximately one operator visit daily. Apache does not anticipate any odors during the drilling or completion of this well since all the gas will be flared. Possible emissions may originate from diesel electric power generation, heavy-duty diesel vehicles and normal light duty gasoline vehicles. During drilling, the rig will have motors running 24 hours per day; however, all directives are adhered to as stipulated in EUB Guide 38 Noise Control Directive. Apache will endeavor to address any traffic, dust and/or noise concerns should they arise.

Surface Equipment

Apache's plans for permanent production equipment associated with this well will be finalized after the well is drilled and more information is available. However, typical production equipment for this type of well are a separator, fluids storage tank, and a meter run building (the separator, and meter-run would all be housed within one building). Further public consultation with respect to pipelines and processing will be completed once a well is proven for production.

Setback Restrictions

A minimum of 100m separation distance will be established and maintained between the well and any surface improvement (as defined by the EUB) except roads (40m), unless specifically approved by all stakeholders. A stakeholder proposing any future surface improvement within this 100m setback distance of the well centre may require consent from the EUB or the local Municipal Authority. This setback is recommended for safety purposes.

A Letter from the Chairman of the EUB

Dear Neighbour,

I am writing to you because a representative of a petroleum company proposing development has recently approached you, and you may have questions. The company plans to make an application to the Alberta Energy and Utilities Board (EUB) for a facility, pipeline, or well (an energy development) on your lands or your neighbours' lands. The EUB requires the company to either notify or personally consult with you before obtaining a licence and provide you with information that may include the documents described below. Whether or not the documents are required, you may request them from the company.

EUB Public Information Documents—These include this letter, the brochure Understanding Oil and Gas Development in Alberta, EnerFAQs No. 8: Proposed Oil and Gas Development—A Landowner's Guide and the EnerFAQs series related to energy development. These documents contain information about your rights and options, as well as the roles and responsibilities of the EUB in the regulation of Alberta's energy developments and how we can help you.

Company's Information Package—This includes sufficient information about the proposed project so that you can understand the facts and potential impacts the proposal may have on you and your family. You will be asked to bring forward any questions or concerns you may have and to go over the specifics of the proposed development with the company representative. The company is required to answer all reasonable questions posed by you.

I encourage you to carefully review the information provided and to meet with company representatives to discuss the proposed development. The conversation should include any measures that could be put in place by the company to reduce potential impacts, alternatives to the proposal that may exist, and the overall future development proposed for your area.

If there are matters that cannot be resolved, the EUB can provide you with more information on its Appropriate Dispute Resolution (ADR) program, which includes EUB facilitation and third-party mediation. Unresolved issues could ultimately result in the EUB holding a public hearing to consider the application. While the EUB encourages all parties to first attempt to cooperatively reach agreement, all should be aware that they have the right, at any time, to request that the EUB hold a public hearing.







I'd like to formally submit my complaint in writing to my taxation assessment. This is an unfair assessment. It seems that as time goes by, it is necessary for the town to increase the amounts assessed for services and I completely understand the need for that. I am not one to complain or make a stink, as I believe that our elected officials will do their job to the best of their abilities. I do, however, feel that there has been some inequality in the assessments this year.

I also assume that the assessor is the one who has made the decisions, but that as town council, you also have some responsibility in this. Because of the recent upswing in the property values, our homes have definitely seen some kind of appreciation, and as such the assessments could be raised. I do question the methodology used. There was no one who visited our home to reassess, or did anyone visit anyone whom I have spoken with. When this is taken into account, you would think that the increase should be a fairly straight across the board increase. This is NOT the case. Some homeowners have had as small as a \$100.00 increase, which would probably translate into less than 5%. Most are about \$200 to \$400.00. Please compare that to an increase in my taxes of \$1440.97, which is a whopping 45.6% increase. This is unacceptable. My home has definitely not increased in value by 46%. The carpets and line are the same as when it was built 21 years ago. It's not a new home! Now perhaps some would argue that having a large yard means more value. Not so, as I'm sure that I wouldn't be able to develop the back 2 acres of the lot with the towns approval. Another home would not be acceptable by you or by me. So there really is no added value of the large lot because development is impossible. Additionally, we at the acreages lack services that the town people have, such as paved road, town sewer, storm drainage, curb, gutter, sidewalk, and street lights as examples. There are few fire hydrants available if an emergency occurred. The inequalities continue, don't they? To be honest, I don't really want these things, but it seems that we are being taxed for them. Apparently the increase is done using recent sales of properties in the area, with the number of 6 being what is required. Which properties were they and what was the price paid and what were the assessments on those? Because of the increase in taxes, our actual value will decrease now because people won't want to buy our property due to the high tax. Will the tax break given to El Molino for 5 years mean that they will be in town for 4 years and 10 months like Richardsons were? It seems that we at the acreages have been hit the very hardest of any in town when compared to new areas. There are homes in town that are of greater value than ours and assessed far less. We feel that we have been targeted. Furthermore, the advertisement in the paper was not as clear as it should have been... there was no mention of a specific form to be used or that there was a \$50.00 fee to appeal. Also, please replace my previous letter with this letter. Again, there was no mention that it was necessary to include all the details of the block and plan number. Greater care should be taken in the future.


I would like to have the Assessment Review Board provide me with their decision in writing, as allowed for in the Municipal Government Act section 469 subsection 2. That way if necessary I can take that decision to the Municipal Government Board for further appeal.




Infrastructure for Proposed Development

Defining the Focus Area:

For the purposes of this report the focus area is the new development that is being proposed in the southeast area of Claresholm.



More specially, the lands proposed for new development could be referred to as any land that borders the eastern boundary of the golf course. The two developers that currently have interest in developing land that fits this description are Christie Estates and Bridge Developments.



Infrastructure for Proposed Development

Identifying Infrastructure Needs:

The Town of Claresholm has retained Cicon Engineering for this project. Cicon has worked in parallel with representatives from these two developments to identify the infrastructure needed to develop the focus lands.

Christie Estates:

- Sanitary Sewer: There are existing sewers servicing the land, however the integrity of these sewers is questionable. Therefore, alternatives were explored.
- Water Supply: Again, the land has access to a water supply; however the pressures and volumes that are currently present will not fulfill the needs of the future residents. Upgrades will need to be made.
- Storm Water Management: The new development is being designed to direct the runoff to the Town's existing management area. (Frog Creek Basin, Golf Course ponds) No projects needed.

Bridge Developments:

- Sanitary Sewer. No sewer currently available
- Water Supply: No water supply currently available
- Storm Water Management: As stated above, the development area is adjacent to the Frog Creek Basin / Golf Course Ponds. Currently contours show that the terrain generally slopes to the south. No Projects Needed.


Infrastructure Projects:

The analysis that has been provided to the Town of Claresholm indicates that the new infrastructure needed will be used by both developments. Therefore the Town of Claresholm has insisted that these two parties work together to find the best and most cost efficient scenarios to provide adequate services for their development. Again the Town's project engineers, Cicon Engineering facilitated this process and have provided the following project results:



Dear Mr. Mayor and Councillors;

The tenders that were received for the construction of the new building for the museum are all much higher than expected. They ranged from \$2,010,000 to \$998,450.

The Museum Board continues to be committed to the needed expansion project for the museum and has worked very hard to make it a reality. The board has raised \$485,000 in cash, a sum that includes \$178,741.45 raised locally, \$125,000 from the CFEP program and \$171,000 from the Cultural Spaces Program of Heritage Canada. The grant from Heritage Canada is conditional on the project being completed by March 31, 2008, so time is of the essence. On June 1st an application was submitted to the Lethbridge Community Foundation for a grant to help with our project.

The Museum Board believes that the expanded museum will better showcase the history of our community, allow the museum to develop closer ties with our schools, make partnerships with other heritage institutions possible, and become an important tourist destination. In 2006 the museum had 9950 visitors, many of whom accessed other amenities in Claresholm. The new building will also provide a safe temperature-controlled environment for our unique collection which is now housed elsewhere in less than optimum conditions awaiting proper display.

The Museum Board therefore requests that the Town of Claresholm consider interim financing for this project. Costs have risen dramatically and this trend is expected to continue. We believe that delay would jeopardize the whole project.

The board will continue to seek donations further and grants for this project. This project will qualify for the new provincial program, Major Community Facilities Program, which has just been announced to address the need for funding beyond the level provided under CFEP. We have the appropriate application form and will apply for this grant right away.

Thank you for your continued support. Together we are working toward a better Claresholm.

PEACE OFFICER PHYSICAL TRAINING FOR DISCUSSION PURPOSES ONLY COMMUNITY STANDARDS COMMITTEE MEETING COUNCIL MEETING JULY 16, 2007

Under the new requirements for peace officer training it is stipulated that a Peace Officer must have the following qualification to obtain their designation:

• Successful completion of an approved physical abilities evaluation test for uniformed enforcement roles. Authorized employers may use a variety of physical evaluation tests but these tests must be reviewed and approved by the Director.

Currently approved tests are:

Physical Abilities Requirement Evaluation (PARE): This is the current standard for many Alberta police agencies and can be completed at a number of institutions in Alberta.

Correctional Officer Physical Aptitude Test.

Other tests may be approved after submission and review by the Director. Successful completion of training course(s) approved by the Director.

The PARE test is a rigorous physical test that must be completed within 4 minutes and 45 seconds to allow the participant to pass. This test must be taken every three years. The rigorous nature of this test may cause current Peace Officers to lose their designations and may deter individuals and communities from applying for Peace Officer status.

This test is the standard test for provincial sheriffs. For the level of service and the duties of community peace officers (level 1) it appears to be too onerous of a standard for the needs of small communities' enforcement personnel.

It has been suggested that municipalities, whom have bylaw enforcement/peace officers and believe these standards are too stringent to enable communities to keep peace officers, talk to other municipal leaders. Communities are encouraged to contact their MLA and petition the Solicitor General to adjust the physical evaluation tests in communities that request it. This could mean that a Peace Officer would be physically examined by a certified physician to ensure their overall good health and do testing to ensure the candidate can perform the duties required.

Currently the Town of Claresholm bylaw enforcement officer, Nigel Young, is training for his PARE test to be taken on July 30th. Once this training has been passed his designation as a Peace Officer will be finalized.

Dear Senator Olson:

Thank you for your letter of 17 April 1986 requesting information on obtaining an obsolete aircraft for the Town of Claresholm.

It is appreciated that Claresholm did provide a major contribution in the training of military personnel during and after WWII and that a suitably displayed aircraft would commemorate that fact. I must with regret, however, advise you that the Department of National Defence does not presently have any obsolete aircraft that can be made available to Claresholm. The Department's surplus CF101 Voodoo and CF104 Starfighter aircraft have all been promised to other organizations with long standing requests and no other types are expected to become surplus until the mid 1990s. At that time the T33 Silverstar and the C47 Dakota aircraft are due to be phased out. However, it would be premature at this time, to make any commitments regarding these aircraft.

Claresholm's request will be added to the directorate's waiting list and should an obsolete aircraft become available, the Town of Claresholm will be notified by my disposal personnel.

I appreciate your interest in preserving our military history and may I extend my best wishes to the Town of Claresholm in future endeavours.

3) Reoccuring Offenders

Committee discussed the reoccurring offenders to the unsightly bylaw: Randy Kaniuk, Mike Petrovic (both residence and business), Kal Tire, Casa Roma, Judith Campbell (both residence and business), Fern Brothers, Ron Strangways, A & J Homes Golf Course lot and miscellaneous lots in corporate limits.

4) Dog Bylaw

Committee was updated by Nigel regarding a visit to Nanton with George Woof, bylaw officer to discuss how he handles stray dogs. Nanton has a kennel set up and only uses one or two kennels. He suggested we contract with Nanton to have our stray dogs brought to Nanton and kept in the kennel there. Nigel would do the administration for the stray and when the owner came to pick up their dog, they would have to pay the fines in Claresholm and then Nanton would be contacted that they can be released.

Any strays that are not claimed would be released to "Heaven Can Wait" a animal shelter in Okotoks.

The system for cats was also discussed. When cats are reported to the Town, they will be checked for tags etc. and to ensure they are not in distress, then the Bylaw Officer will contact "Heaven Can Wait" to have them picked up.

5) General Issues

Nigel discussed the door hangers he is having made up for residents in contravention of bylaws. He is also reviewing the bylaws and will be making recommendations for changes in the future. He is contacting all property owners who are in non compliance regarding grass or unsightly properties and will give the Committee an update at the next meeting.

The Committee will meet every two weeks for the summer on Wednesdays at 5:30 pm until the Bylaw Enforcement issues are caught up and the systems are in place where less frequent meetings are sufficient.
