Information

OVERVIEW

A xeriscaped garden with native plants in this area will be both an educational and beautification enhancement to the downtown core.

DRAFT Project Proposal: Prairie Urban Garden Demonstration in Claresholm

Project Description:

The OWC's Urban Team and its partners in Claresholm would like to create a xeriscape in Claresholm to encourage homeowners to adopt the principles of xeriscaping at their own homes. Xeriscapes, or Prairie Urban Gardens as we like to call them, are attractive and have a low environmental impact because they are designed and maintained in harmony with our dry prairie environment. This project will be successful because the partners are committed and capable. The Town of Claresholm is taking responsibility for ensuring the garden is completed and maintained, with assistance from Communities in Bloom and the Claresholm Garden Club. The garden will be located in a highly visible area where a garden currently exists. The existing garden will be improved and signage will educate visitors about xeriscaping principles and the garden itself. Garden design and planning will commence immediately with landscaping to be completed as soon as possible in spring 2011.

Urban Team:

The Urban Team promotes good practices for the home and yard because the river starts in our own backyards. Herbicides, fertilizers and other chemicals used in yards are showing up in our waterways, affecting aquatic life as well as downstream users. The Urban Team also promotes water conservation because we live in a semi-arid environment where water is scarce and drought is common.

Goals:

- 1. To demonstrate the beauty and benefits of having a xeriscaped garden in Claresholm.
- 2. Inspire Claresholm homeowners to adopt xeriscaping principles.
- 3. Prove the principles work well in the area and do not sacrifice beauty.
- 4. Provide practical information (plants to use, mulching and water requirements) locally through the project partners and at <u>www.prairieurbangarden.ca</u>.

DRAFT MEMORANDUM OF UNDERSTANDING

The Oldman Watershed Council hereby grants the sum of \$8000 to the Town of Claresholm who hereby agrees to the following terms and conditions:

THE OWC URBAN TEAM AGREES TO:

- To provide the applicant with contacts and information that will ensure the garden is designed and installed properly in that it follows the 7 principles of xeriscaping.
- Provide financial assistance for project.
- > Monitor the progress and completion of the project from its inception.
- > Assist with promotion of the garden.
- > Provide a sign(s) explaining xeriscaping principles and their importance.

THE TOWN OF CLARESHOLM AGREES TO:

- Take on the responsibility of hiring a landscape designer who is familiar with xeriscape principles, contract a landscaper (if needed), purchase the plant species and install the garden to its completion.
- Acknowledge the Prairie Urban Garden (PUG) project for its contributions by allowing a sign(s) to be posted at the project site. A sign(s) will be provided by the OWC.
- > Display the OWC and PUG logo on all publications relating to the project.
- Allow access to site for field trips, tours, monitoring, media, etc. for up 5 years after project completion.
- > Allow OWC Urban Team to profile the project on the OWC and PUG websites.
- Release the OWC and its agents from liability of licensing or regulation requirements.
- > To manage the xeriscape in such a way that will support the OWC goals.
- Complete the xeriscape in a timely manner while following the 7 principles of xeriscaping.
- > Spend the funds only on the xeriscape garden as agreed.
- Maintain the xeriscape over the long term including weeding, watering, adding mulch, etc as needed.
- Provide any extra funding above and beyond the sum stated above, if the project requires so.

Make it Official

Trade-marks, Official Marks, and the Benefits of Registration

In my first article,¹ I wrote about the importance of a municipality protecting its intellectual property assets. Here, the focus is narrowed to examine registered trade-marks and official marks, both potent weapons for protecting your municipal brand.

First, let's review the rationale for registration.

Why Register?

"We've been using the town slogan since 1975," you may say. "Surely this is ours! Why bother with registration?" Perhaps that slogan is yours. What "yours" means, however, can get a little murky. Are you sure you "own" it? How far does your "ownership" extend? What are your rights? A registration answers these questions. Not having a registration is kind of like standing on a bath mat when what you need is properly-installed wall-to-wall carpet. And, if you're not paying attention, it can get yanked right out from under you.

Let me explain.

Does the fact that you paid someone to create a logo prove that you own it? No, not necessarily. Does a municipality's longstanding use of a mark provide some protection? Not automatically. In both cases, what you have in your hands is merely evidence. Unregistered trademark rights are extremely dicey and by no means automatic. You have to earn those rights and you do that by bringing pounds of evidence to court. Expert evidence. Survey evidence. Samples of letterhead, ads, and signage going back years and covering as much geographic territory as you can muster. As you can imagine, this is expensive, time consuming, and risky. Did I mention expensive?

In comparison, imagine standing in court and handing the judge a single piece of paper: a trade-mark registration. The judge will turn to the other side and ask, "What is your defence?"² Most of the time, you won't even get to court because, in the face of a registration, the other side has a tendency to turn on their heels and run for cover. That doesn't always happen, of course; but, in my experience, it happens about 80 percent of the time.

Isn't that worth the investment? Not sure? Then let me ask you this: How much will it cost taxpayers if someone trade-marks your brand out from under you and then holds you for ransom? Believe me, it happens and it is a tough problem to fix after-the-fact.

Having established the "why" of registration, let's consider the "what" and "how." Here we will review two types of statutory trade-mark protection available to municipalities – registered trademarks and official marks – and why the latter is such an attractive option.

Registered Trade-Marks – A Quick Summary

A Canadian trade-mark registration grants legal ownership across Canada. Any person using a "confusingly similar" trade-mark is an infringer, as is anyone who uses a registered trademark with the effect of depreciating the owner's goodwill.³ The *Trade-marks Act* arms owners with heavy-duty recourse against infringement, including money damages, injunctions, and delivery or destruction of infringing goods and advertising materials.⁴

To achieve registration, trade-marks undergo a rigorous, multi-staged application process – including a two-month period wherein anyone may challenge the application by filing an "opposition." If all goes well, the process may take 12-18 months. If an opposition is filed, it can take years.

Registered trade-marks are subject to some limitations. They are not global in their application. Rather, trade-mark protection is restricted to a specified area of trade except in rare circumstances of extraordinary fame. There are also prohibitions against clearly descriptive words ("the bread bakery") and registration will be denied if there is a confusingly similar mark already registered.⁵

The most powerful brands in the world have built empires on the backs of their trade-mark registrations. Official marks come with similar exclusivity, but subject to a less stringent process and fewer limitations. Official marks protection is so potent as to border on intellectual property expropriation.⁶

Official Marks – In Support of Public Order

Section 9 of the *Trade-marks Act* creates special protection for various public authorities, including municipal governments. Intended to support public order, section 9 consists of a lengthy list of "prohibited marks" that may not be adopted by the public for commercial use. The list includes, for example, the arms or crest of the Governor General or any member of the Royal Family, the Red Cross and territorial or national flags.

Official marks are a subspecies of the "prohibited mark" family and are distinguished by their open-ended definition:

any badge, crest, emblem or mark ... adopted and used by any public authority in Canada as an official mark for wares and services ... in respect of which the Registrar has, at the request of ... the public authority, given public notice of its adoption and use.⁷

In practical terms, that section translates to the following process. If a municipality has used⁸ a mark, it may file a request, pay a fee, and submit evidence to the Registrar of Trademarks. Public notice is then advertised in the *Canadian Trade-marks Journal* and – poof, official mark status takes effect for that mark.

MUNICIPAL WORLD

Why Official Marks Rule

There are a number of reasons why a municipality might choose an official mark over a registered trade-mark.

1. Quasi-expropriation – no opposition process – Where trade-mark applicants must publish their intentions and face potential opposition, there is no such provision for public challenge in respect of official marks. Nor does the Registrar of Trade-marks have discretion to refuse a municipality's request for publication, provided that the public authority can provide evidence of adoption and use.⁹

2. No limits based on wares/services – Unlike registered trade-marks, there is no requirement that a public authority limit its rights to a list of wares and services. Official mark status comprises a blanket prohibition against any person using the mark in commerce. Period.

3. No limits on the basis of descriptiveness or prior registrations – A regular trade-mark applicant is prohibited from registering a mark that is clearly descriptive of its wares/services. The owner of a grocery store, for instance, cannot register "the grocery store." There is no such restriction on official marks. Furthermore, a public authority can register an official mark – despite any preexisting trade-mark registration for the exact same mark. Ordinary trade-mark applicants do not have that luxury.

4. Simpler process, less expensive – The process for obtaining official mark status is significantly simpler and more streamlined than the trade-mark application process. As a result, it is much faster and less fraught with peril – and the overall expense of the process is less costly.

5. Permanent protection – The effect of official mark status is permanent, whereas registered trade-marks are limited to a 15-year, albeit renewable,

term. Further, official marks are virtually unassailable. Registered trade-marks are susceptible to attack for non-use, abandonment, or invalidity. Official marks are far less vulnerable, there being no statutory procedure for their review.¹⁰ This is especially true in the case of municipal governments, as there is no question as to their status as public authorities.¹¹

Parting Thoughts

If your municipality is making use of logos, slogans, crests, flags, or other means of marketing and identifying itself, then you have trade-mark issues on your hands. The very best protection for your marks is to register those rights. Certainly, trade-mark registration is a viable option for municipalities. However, making a request for an official mark may be the best investment for the money. MW



TOWN OF CLARESHOLM CAO UPDATE AS AT OCTOBER 25, 2010

- 1. **PINE COULEE WATER PROJECT** The full project is finished. The WTP operators are still working some programming issues out with the engineers and the contractors for the membrane filtration sytem.
- 2. **WEST WATER CO-OP PROJECT** The project is complete and the invoice has been paid by the Co-op for their share of the project. An agreement with the Co-op will be brought to the Utilities Planning Committee for review and approval prior to it coming to Council. This agreement will cover such issues as reading meters and a cost and the land the Coop's pipeline is situated which is owned by the Town.
- 3. **SOUTH SANITARY SEWER PROJECT** This project is also finished and all grant funding has been applied for. Any deficiencies have been dealt with and the holdback has been released.
- 4. **2010 INFRASTRUCTURE PROJECTS** BowMark Paving Ltd. has finished both the pave of 8th Street and the storm sewer and lane project. The Town has not released the holdback yet.
- 5. DEVELOPMENT Harvest Square subdivision continues to move forward as all paperwork for registering the subdivision has been sent to Land Titles. Developer will be onsite to finish infrastructure and fix existing foundations etc in November (per discussions with their representative). Nothing to report on Christie Estates, Bridge Developments or Prairie Shores developments. Saddle Ranch Development continues to market their properties.
- 5. **HOLIDAYS** –Public works and Administration staff continue to take holidays to ensure no accumulation. Now that the WTP project is complete, both Jerry and Brad will be taking holidays (not at once) to reduce the holidays they have been accumulating.
- 6. ASSESSMENT APPEALS One Local Assessment complaint was heard by the Board. No Composite Assessment complaints were heard as all complaints were withdrawn.

7. MISCELLANEOUS -

Playground Redevelopment – This year we redeveloped Patterson Park (east side) with CFEP monies and town monies saved for playground reserves. The park was completed October 22, 2010. The next playground redevelopment will be Westhills Park or Lions Park in 2012.

Tax notice deadline – There has been discussion between staff and Councillors previously whether the deadline to have tax notices sent out should be earlier (currently they go out in May). Due to the next regulations for the appeal process, the complainant has 90 days to appeal their complaint (August). If it is a non residential complaint the process is a minimum of 70 days to the hearing (October). The timeline is 35 days for a residential complaint. Further discussion and details on this issue will be forthcoming for Council on the next agenda.

CONCLUSION – This is a brief overview for Council. A monthly CAO report will be on the agenda to keep Council apprised of projects/ events they need to be aware of.

The deadline for all nominations (except Vice-Presidents) is 4:30 p.m., Wednesday, November 10, 2010.

Nominations may be filed with the AUMA office (by fax to 780-433-4454 or e mail to <u>ReturningOfficer@auma.ca</u>) any time between October 22 and 4:30 p.m. on November 10. Nominations must be signed by two nominators who are eligible to vote in the election for the position.

Positions Available for Election

The positions available for election in 2010 are

- (a) President
- (b) Vice-President Cities under 500,000 population
- (c) Vice-President, Towns
- (d) Vice-President, Villages and Summer Villages
- (e) 1 Director from cities up to 500,000 population
- (f) 1 Director from each of Towns West and Towns South
- (g) 1 Director from each of Villages East and Villages West

Elections begin at **8:00 a.m., Thursday, November 25, 2010**. The President election is held first, followed by the Director elections and the ACFA nominee choice. Following a recess, the Vice-President elections are held.

ACFA Class D Director

Class D shareholders of the Alberta Capital Financing Authority (towns and villages which are ACFA shareholders) are eligible to nominate, and vote for the selection of, a person to serve as ACFA Class D Director for the 2011-2014 term of office. The nomination deadline is November 10, 2010.

In 2004 AUMA established a procedure to enable Class D shareholders to select a person to be nominated as the Class D Director at the forthcoming ACFA annual meeting. The process was repeated in 2007. This selection must be made at the 2010 Convention. The current ACFA Class D Director is Whitecourt Mayor Trevor Thain. An ACFA Director may be an elected or appointed official. As noted above, if the nominee is an elected officer, the Returning Officer will not be able to accept the nomination until October 22, 2010.
