

#### TOWN OF CLARESHOLM PROVINCE OF ALBERTA BYLAW # 1598

A Bylaw of the Town of Claresholm to amend Bylaw #1510 being a bylaw respecting waterworks, sewers and plumbing in the Town of Claresholm.

**WHEREAS** it is deemed expedient and proper pursuant to the provisions of the *Municipal Government Act* that the Council of the Town of Claresholm shall issue a Bylaw to amend its existing Water & Sewer Bylaw.

**NOW THEREFORE** under the authority and subject to provisions of *Municipal Government Act*, the Council of the Town of Claresholm duly assembled does hereby enact;

1. The Town of Claresholm Water & Sewer Bylaw #1510 shall be amended as follows:

**REMOVE:** Current Section 13.7

13.7 When water service is inactive, the basic sewer and garbage rates will also be deemed inactive.

**ADD:** Revised Section 13.7

- 13.7 When the water service has been shut off and is inactive, the basic water, sewer, garbage and recycling rates will continue to apply.
- 2. This Bylaw shall take effect on the date of final passage.
- 3. Bylaw #1510 is hereby amended.

To celebrate this momentous occasion, the Town of Fort Macleod is honoured to have been chosen to host the world famous RCMP Musical Ride on the night of August 7<sup>th</sup>. The RCMP Musical Ride will feature a full troop of 32 horses and riders. The RCMP initially started out as a cavalry regiment known as the North West Mounted Police. It has a rich history with its officers on horseback and strong historical ties to the Town of Fort Macleod.

"We are so excited to have this opportunity to come together as a community to celebrate the rich history of Fort Macleod," said Councilor Trish Hoskin. "We have so much to be proud of here: our town, the legacy of such great historical significance for the country, and most importantly, the people of Fort Macleod."

There are various events planned throughout the day, at The Fort Museum, The Empress Theatre, on Historic Main Street, and at NWMP Barracks site, culminating with an evening of entertainment at Midnight Stadium. With performers ranging from Can Can girls to trick riders, gunfighters to lawmen, Leon Goodstriker's Indian Games, singers, pipers, Aboriginal drummers and dancers, as well as horses of all shapes and sizes, this event is guaranteed to have something for everyone.

"The founding families in our area literally carry the ancestry of Canada's brave and resilient pioneers, and our First Nations' neighbours in their blood — keeping our history alive. It's high time we celebrate that!" said Councilor Hoskin.





Hi Cindy,

As discussed earlier, pursuant to Section 72 of the *Municipal Government Act*, because the MD is planning to acquire land located within the geographic area of another municipality, written consent must be obtained from the municipality within whose jurisdiction the land is located.

#### Acquisition of land outside municipal boundaries

72(1) A municipality may acquire an estate or interest in land outside its boundaries only if

(a) the council of the municipal authority in whose boundaries the land is located consents in writing to the acquisition or, in the case of a municipal authority that is an improvement district or special area, the Minister consents in writing to the acquisition,



Dear Mayor Steel and Council:

I am submitting this letter with my 2014 property tax payment. I am paying my taxes under protest due to the following reasons:

- 1. The terrible road conditions in the Mountain View/Saddle Mountain subdivision in south Clareshom. The roads have been especially horrible this spring, being impassable for much of the spring. This has been an ongoing problem for years now and nothing seems to be done to prevent this from happening. A permanent solution to this problem needs to be found.
- 2. The terrible condition of 8<sup>th</sup> Street West from the cemetery all the way to the Hoffman Farm. This road was never done properly and is very rough. It consists mostly of potholes, pothole patches and broken cold pack which is very rough and crumbling more and more everyday.
- 3. The ditch (moat) that was dug in front of my property. This ditch is pretty much impossible to maintain. The sides are so steep I cannot properly mow the little bit of grass that has grown on part of it. It is so deep that the bottom is always wet so that I cannot even get into it to try to keep it looking nice. # Municipal Park Events Policy #REC 07-14

**PURPOSE:** 

To establish a consistent policy regarding the use of Municipal Park Facilities by the public for the purpose of charity or non-profit events. Events in community parks enhance the quality of life, provide entertainment, promote local economic health, attract visitors, and contribute to the dynamic atmosphere of the community.

#### **POLICY:**

In addition to the normal use of municipal parks, these areas are also meant to be used for special events. Not-for-profit organizations (or charity groups), may use the municipal park facilities at the discretion of the Chief Administrative Officer (CAO) of the Town of Claresholm.

#### **PARAMETERS:**

Formal requests to use any Municipal Park for any event must be presented to the CAO in writing (email or letter). The request must include details of the event such as:

- Date(s) and time(s) of the event
- Location(s) of the event
- Exact premises involved (use of structures of facilities, ex: restrooms)
- The name(s) of the individuals and/or groups involved
- The exact reason for the event
- The signatures of all parties involved

Requests should be submitted 14 days prior to the scheduled event to allow the Town of Claresholm appropriate amount of time for review and preparation of the municipal park facilities accordingly. Requests submitted on a shorter timeframe will still be considered, but restrictions may apply. A detailed sketch may be required with the request if you plan to use an outdoor tent, equipment, trailers, stages etc. Any requests for the use of Municipal Park Facilities that are for profit purposes or private functions will be referred to Town Council for approval. All users, regardless of usage, may be required to enter into a User Agreement.

#### NOTE:

The Town of Claresholm Administration will review each request and provide written response to the involved parties. The event must adhere to applicable Provincial, Federal and Municipal regulations. If an event is found to contravene Provincial, Federal or Municipal regulations, bylaws or policies, the event may be shut down immediately and future use of these municipal park facilities may be restricted from the user.




